A) WARNING DUE TO CONTROVERSIAL TOLERANCE AND EVEN CO-FINANCING RECORD CORRUPTION IN THE REPUBLIC OF SLOVENIA BY THE EU IN CERTAIN TOTALLY CONTROVERSIAL INTERVENTIONS IN A PROTECTED NATURAL ENVIRONMENT

AND

B) COMPLAINT DUE TO A VERY CONTROVERSIAL, UNCONSTITUTIONAL AND INADMISSIBLE IMPOSITION FOR THE CITIZENS OF THE REPUBLIC OF SLOVENIA OF VERY DANGEROUS MICROWAVE TECHNOLOGY 5G (ALSO WI-FI) BY THE EUROPEAN COMMISSION... IN THE THIRD POINT OF THE EU RECOMMENDATIONS TO THE REPUBLIC OF SLOVENIA ON 20 MAY 2020

Dear Madam President of the EU Commission.

A) As early as January 6, 2016, some brave citizens of the Republic of Slovenia – farmers in Slovenian Istria, with a written complaint and an application for assistance, turned to your predecessor, the President of the EU Commission, Mr. Juncker in person, due to incredible corruption in the bodies of the Republic of Slovenia, which inadmissibly allowed controversial plans for the construction of 5 golf courses on 350 ha of the best agricultural land in Slovenian Istria and for the construction of the disputed chemical factory Lakirnica Magna on 100 ha of the best agricultural land and water protection area for drinking water for 300 thousand people, in the municipality of Hoče – Slivnica near Maribor, both for foreign investors. On December 4, 2018, we again sent an emergency to the same letter. There is no answer yet.

At home in the Republic of Slovenia, we applied in writing to all institutions (including the police, the state prosecutor's office, the government...) but no one was responsible for anything and did nothing to insure the best agricultural land against the golf courses, etc. The plan was for a golf course on 66 ha of the best agricultural land also in Sečovelje by the sea. It is very important that already in 2010, the Republic of Slovenia had the least arable land per person in the EU (only 852 m², and the average in the EU is 2000 – 3000 m² per 1 person). So this is the reddest STOP and alarm for the Republic of Slovenia regarding the best agricultural land.

Within about 20 days, a written notification came from President Juncker's office that our complaint has been assigned to the EU Commission's Fraud Office, which would continue the proceedings and inform us of the result. Until today after about 10 years, there has been no response from the EU from anyone.

According to a German poll, corruption in the Republic of Slovenia reached a record this spring, even the highest – 1st place in the world, and covered practically all institutions in the Republic of Slovenia.

We citizens are practically without effective protection, including constitutionally guaranteed, basic rights in some of the worst concrete cases:

1. Plans for golf course in Sečovelje are now being adopted even on 140 ha of the best agricultural land and no longer on 66 ha of that land, as was the case in the beginning in 2002. Even the Ministry of Agriculture under Minister Aleksandra Pivec has already signed the controversial first consent for the golf course there and the Ministry of Economy under Minister Počivalšek has already signed the first consent for the golf course in Sečovelje, on 140 ha of the best agricultural land for a foreign investor from Serbia. The state prosecutor's office has not yet filed an indictment after 16 years. So there is a total corruption at the top of the state of the Republic of Slovenia.

2. The Magna Factory, that uses car paints, has already been built in municipality of Hoče – Slivnica on 100 ha of the best agricultural land and in the water protection area for drinking water for 300 thousand people. 9 articles of the Constitution of the Republic of Slovenia and 7 undisputed laws of the Republic of Slovenia were violated... and public prosecutor's office has not taken any action since October 2018. It has even twice replied that it does not see any irregularities, even though the Ministry of the Economy has unjustifiably and completely controversially transferred as much as 18 million EUR to Magna. The environmental inspectorate is not taking any action either. So even with Magna, as with the golf course..., there is total corruption at the top of the state and a lot of damage to the Republic of Slovenia.

3. The Ministry of the Environment and Spatial planning of the Republic of Slovenia (MOP) has very controversially allowed the construction of a new sewerage system for the City of Ljubljana over the highest secured drinking water for the City of Ljubljana for over 300,000 people. EUR of EU Commission assistance, allegedly with 80 million EUR from EU funds. In doing so, they completely ignore the Constitution and the laws of the Republic of Slovenia and controversially violate all the rights of owners – including farmers on their best agricultural land. The new Minister at the Ministry of the Environment and Spatial Planning from the SDS party, Mr. Andrej Vizjak, does not even perform supervision or audits legally to completion. The environmental inspectorate did not take any action after several reports. In this case too, there is total corruption at the top of the Republic of Slovenia.

4. Investors have already started building the 2nd track of the Koper – Divača railway line, also with the incredibly inadmissible help of the EU respectively the EIB with a 250 million EUR loan and additional 90 millions EUR of aid from the EU Commission for this disputed route. This is completely contrary to the Constitution of the Republic of Slovenia and the EU Directives, also contrary to Natura 2000 and is also the violation or destruction of the most protected natural habitats in the valley – Glinščica nature reserve, also with a new threat to drinking water for 100.000 people in Slovenian Istria, across the water protection area... This is going on with the inadmissible help from the EU or European Investment Bank (EIB), despite total corruption, of which they were informed in writing by nature conservationists from the Republic of Slovenia. The EIB, the EU Commission, the EU Ombudsman and the EU Fraud Office have been informed about it. This is despite the manufactured and presented alternative route, which completely avoids the water protection area and is approx. 50% cheaper. In this case too, Mr. Vizjak from SDS party,

Minister at the Ministry of the Environment and Spatial Planning, does not want to conduct legal audits of procedures, despite many disputes...

Corruption is therefore complete in this very controversial construction, not only in all bodies of the Republic of Slovenia, but also in almost all bodies of the EU. Even in the case of this highly controversial construction of the 2nd railway track, the Constitutional Court of the republic of Slovenia has twice completely unfoundedly »rejected« the constitutional initiative of nature conservationists and landowners, with an extremely inappropriate explanation that »this is a constitutionally legally insignificant issue«.

It is outrageous that the constitutional right to healthy drinking water for 100.000 people in Slovenian Istria, violations of Natura 2000, the destruction of the nature reserve Glinščica, etc. Are an irrelevant legal issue for the Constitutional Court of the Republic Of Slovenia. The decision was even unanimous. All nine judges voted in favor.

Who else can we turn to – disappointed and desperate citizens of the Republic of Slovenia, people from Slovenian Istria, farmers, nature conservationists etc... from the Republic of Slovenia, when everything here has already given up due to the corruption? Only to you, dear Madame President... Or should we turn to the Vatican? Or the NATO pact, which also defends democracy in its acts? We first address you personally... as the President of the EU Commission.

Therefore, we ask you personally to forward these 4 nature protection points to your competent institutions (something owed to us by the EU Commission from the time of Mr. Juncker... about the golf course and Magna on the best agricultural land), which this time must complete the complaint.

It is necessary to secure EU funds; 80 million EUR for the disputed sewerage and 340 million EUR for the even more controversial 2nd railway track, as the EU cannot and must not finance such controversial plans from EU funds, to which the citizens of the Republic of Slovenia also contribute. This would destroy natural habitats, Natura 2000 and endanger drinking water for 100.000 people in Slovenian Istria. Points 2, 3 and 4 concern the endangerment of drinking water for a total of 700.000 people in Slovenia, which is more than a third of the citizens of Slovenia, all contrary to the regulations of the Republic of Slovenia and all knowingly illegal!

We kindly ask at the end of the proceedings in these points for a written response within a reasonable time.

IN OUR OPINION, SUCH A CORRUPTED AUTHORITY IN THE REPUBLIC OF SLOVENIA DOES NOT HAVE ANY BASIC CONDITIONS FOR THE PRESIDENCY OF EU MEMBERS IN 2021 – THEY MUST FIRST MAKE VERY STRONG EFFORT IN ELIMINATING THIS CORRUPTION ...

B) Dear Madam President, at the beginning of the second part of this warning or complaints due to the very controversial policy of the EU Commission towards all citizens of the Republic of Slovenia, we must first emphasize that at the beginning of your term of office you gave us great hope and trust, since we learned that you are a mother of seven children, that you have many grandchildren, that you are a heartfelt and humane person, that you chose half of the female members of the Commission, which also confirmed greater humanity, compassion, intuition and natural honesty in the new Commission. We know that the male »ratio« or reason is less compassionate towards people, is more calculating and cold...

You also talked a lot about »green« policy (my wife and I also have a small organic farm and have been selling our high-quality organic products on the market in Ljubljana for the last 23 years), and we farmers in the Republic of Slovenia also advocate for green policy.

To our great surprise and disappointment, at the end of May this year you and the EU Commission... adopted a package of financing EU aid to EU members due to the consequences of the »corona COVID-19 crisis« and set two conditions for aid:

**a) green program – which we strongly support as citizens in the Republic of Slovenia and
b) the digitalization program of the country with 5G, which is unacceptable for us in the Republic of Slovenia in the proposed manner.**

It is further in the recommendations of the commission for the Republic of Slovenia dated 20.5.2020 in point 3, written very concretely: »**introduction of the 5G network**«, which is understood as 5G wireless technology (abbreviated: 5G).

We do not oppose digitalization by cables or by wires, as data transfer via optical cables is 10 – 100 times faster than 5G wireless technologies. We have already installed optical cables for telephony practically all over the Republic of Slovenia.

However, we do not agree or accept wireless 5G in the Republic of Slovenia in any way, because of the following indisputable and completely justified reasons:

1. In the Republic of Slovenia we have (as you probably already know in the EU Commission) from 5.12.2019 valid moratorium or suspension of all proceedings relating to microwave wireless 5G, because the former honest brave and competent Minister Mr. Rudi Medved withdrew the Radio frequency management strategy, which is basis for 5G adoption, from the agenda of the 7th session of the Government. This was also due to health risks and possible dangerous effects of 5G on human health, on the basis of Article 8 of the Environmental Protection Act (ZVI-1), which determines the »precautionary principle« for new technologies like 5G. Thus, this controversial strategy has not been adopted in the Republic of Slovenia to date and it is not permissible to allocate frequencies for 5G technologies. The EU has also a very well-defined precautionary principle. Microwave 5G, on the other hand, is an untested and unconfirmed technology and has been shown to be dangerous to human health.

This legal fact – the moratorium on 5G – must also be fully taken into account by the new Minister Mr. Koritnik at the Ministry of Public Administration, the Government of the Republic of Slovenia, as well as the EU Commission.

The Constitution of the Republic of Slovenia for such cases of 5G testing in Article 18 requires the free consent of citizens for this experiment, the Criminal Code of the Republic of Slovenia (in Article 314) punishes such an act of disputing the dangerous use of untested disputable devices with 5 years of imprisonment. However, if there is a mass danger, the same law treats such acts in Article 101 as a crime (as genocide – as defined in the UN Declaration of Human Rights) and prescribes a sentence of at least 15 years in prison. Article 105 of the Criminal Code stipulates 5 years of imprisonment for soliciting controversial acts under Article 101 of the Criminal Code. Since the end of May this year, the EU Commission has also been »inciting« to the crime under Article 101 of the Criminal Code! Are you all in the EU Commission aware of this?

As the new Minister at the Ministry of Public Administration is trying to circumvent this undisputed moratorium on 5G in the Republic of Slovenia and there is a suspicion of endangering human health, proceedings are already underway against him before the police and the State Prosecutor's Office.

On December 4th, 2019, we from a non government organization Združenje sonaravnih kmetov Slovenije (ZSKS), sent a sharp and well-argued letter to Minister Mr. Rudi Medved, with much evidence – studies by world scientific experts on health hazard already with 2G-4G and even more so with 5G wireless technologies. This letter was decisive that the Minister immediately after, on 5th December 2019, as a precaution, withdrew the Strategy for radiofrequency management (needed for 5G implementation) from the procedure of adopting at the session of the Government of the republic of Slovenia.

This is one of the reasons why we farmers and nature conservationists cannot agree, even more to someone from »outside« or from »above« from the EU, not even you, Madame President of the European Commission, or whoever else, who would try to impose this microwave danger and doom for people in a controversial and inhuman way to the people in the Republic of Slovenia. Also the EU Commission must not impose this on us in the Republic of Slovenia, not in any way – not even with the disputed conditionality for EU assistance to Slovenia in the amount of 5.1 billion EUR. Severe sanctions would follow for all those responsible according to the regulations of the Republic of Slovenia and according to the UN Declaration and also according to the law of nature, which stipulates: what you sow, you reap.

We therefore believe that it would be utterly unfair for you in the Commission to make EU assistance to the Republic of Slovenia conditional on 5G wireless, but you can request a digitalization with optical cables, for which the Republic of Slovenia has good conditions and we agree to that safe and efficient technology.

2. Brussels, the capital of Belgium and the seat of the EU Commission, also has a moratorium on 5G wireless technology. We read in the media the statement of the competent person in power in Brussels, who clearly, decisively and bravely said: »We will not be guinea pigs for 5G«.

3. A moratorium on microwave 5G technologies has also been declared in Geneva, Switzerland, where the WHO is also headquartered.

4. In March of this year, the relevant research agency of the EU Parliament also decided that 1996 guidelines on permitted radiation were outdated and could not be applied to 5G, as it is

a completely new technology with different characteristics than 20 years ago. They also decided and wrote an opinion for the briefing of the EU Parliament representatives, that new scientific research on 5G is needed. The EU Commission must in any case and absolutely take into account the acts and findings of the working body of the EU Parliament, as it was appointed by the EU Parliament.

Document – this proof is attached.

5. A Spanish study on connection – correlation between 5G networks and COVID-19 disease or Coronavirus deaths by regions of Spain (produced at the end of the worst period this spring) confirms facts in point 7 as there were 400 to 800% more deaths due to COVID-19 in regions with dense 5G networks compared to regions with less or without 5G.

This study is also in the attachment and there is no reason to doubt it, as it is common knowledge that microwaves in the microwave ovens cook, bake or fry meat, tissue, etc. in a matter of minutes. 5G transmitters and phones are the same or even much more severe microwaves, but no security door like by the kitchen oven...

6. A short video (13 minutes) of the lecture of prof. Martin Pall – a doctor of biomedical sciences and physics – briefly, simply, clearly and very professionally tells the most important things about the dangers of WI-FI, 4G and 5G for human health and for the nature. Anyone who has honest human nature and discernment in their head and heart should listen to this short video and follow it. Remember that this plan to wirelessly »digitalize« EU members comes mainly from the USA and China, which in many areas are unfair to their citizens and to the EU and look primarily at their narrow interests.

7. Dear Madam President,

Your predecessor Mr. Juncker provided EU members and also Slovenia with a dangerous microwave Wi-Fi technology, which was then imposed on almost all public institutions in the Republic of Slovenia (kindergartens, primary schools, nursing homes, hospitals) by our politicians, who are poorly educated on the effects of Wi-Fi below the permitted standards for safe exposure to microwave radiation. As much as 15.000 EUR of »co-financing« from EU funds was available for this project. Thus, in the autumn of 2019, most primary schools in the Republic of Slovenia have already installed Wi-Fi in classrooms and we already had almost 450% more flu cases in the children and total population of the Republic of Slovenia- This was the first winter with Wi-Fi devices in schools and with many complications from the flu in the population of children.

We nature conservationists in the Republic of Slovenia have been trying for more than 6 months to convince the competent ministers to disconnect and remove these dangerous Wi-Fi devices from public spaces as soon as possible, as they have been scientifically proven to destroy the immune system from above classroom ceilings, especially because children have thinner skulls. Then the viruses develop rapidly in the child and spread rapidly to others. 369.000 of the youngest in the Republic of Slovenia (including high school students), the flower of the nation or 18.5% of all people in the Republic of Slovenia are being attacked by microwave Wi-Fi radiation.

Consequently due to this dangerous mistake of the EU Commission headed by Mr. Juncker, we have many health problems in children population and even greater problems in the nursing homes. As many as 80% of all deaths due to COVID-19 were among elderly from the nursing homes with Wi-Fi installation in their rooms. All of the previously mentioned was a result of the

Mr. Juncker's following the directives of the USA institutions under the presidency of Mr. Barack Obama, which indoctrinated the Wi-Fi to the EU members in a hostile and unhuman manner.

8. Dear Madam President,

We must also emphasize that our country had the lowest number of deaths from COVID-19 in the EU per 1 million people (only 54, while our neighbouring country Italy had as many as 1.600) and is even among the healthiest in the world in terms of coronavirus. Our country was also the first in the EU to cancel the COVID-19 epidemic. All of this, however, may be precisely because of the moratorium on 5G, because we do not have 5G wireless microwave radiation in our environment. The Prime Minister is perhaps not yet aware of this, but may eventually realize the benefits of being a 5G network free country, if it isn't too late for him when he does.

The indisputable fact, however, is that EU Commission must not impose dangerous 5G on us and unfairly condition EU aid on the introduction of wireless 5G technologies. This would be very immoral, inadmissible and criminal, as this could consequently mean that should there be a new similar corona crisis, we might have 30 times more deaths than we have had now, as was the case recently in the neighbouring Italy, just because of your imposition of the dangerous 5G technology to the Republic of Slovenia!

9. We therefore suggest that you define for Slovenija »introduction of digitalization with optical or other cables only« and absolutely no wireless 5G technology! The Republic of Slovenia can be a pilot example of a country without the dangerous 5G and it will continue to be so to set a positive example for all the members of EU – a 5G free country!

10. Due to the EU directives allowing it, we have 10 times more aluminum in our drinking water in the Republic of Slovenia than before, when we were independent, as this is supposed to be »necessary« for disinfection of the drinking water. So the cases of Parkinson's, Alzheimer's and dementia disease in Slovenia have increased and are still increasing and this is also the »Danaian's gift of the EU« to Slovenia. This is very wrong and unfair to the people – the EU citizens!

11. It is very similar with the »permitted« levels of pesticides in the drinking water. We used to have a permissible limit of 0.1 micrograms per 1 liter, but since last year the limit has been changed to 0.5 micrograms per 1 liter, which is 400% more as the EU directive »allows« so, the authorities answered, and now we could drink 4 times more toxic water. Another »Danaian's gift« for us citizens of the Republic of Slovenia from the EU.

Dear Madam President of the EU Commission, the highest executive body of the EU!

EU politicians often like to say that the EU is a large family of nations with almost 500 million citizens. You personally, Mrs Ursula von der Leyen, are symbolically the mother of this great family of the EU. You were born under a very honest constellation which represents justice, humanity, compassion, love, art, even tenderness... many positive values. Your moon in the Leo sign suggests a great leader who must follow and be true to the honest values of her »star« and therefore be an honest leader to her large family of fellow humans in the EU.

You took up the position of the President of the EU Commission on December 1st 2019 (that was the day of my 67th birthday, I am lawyer by profession and retired since December 2015). Since you are quite »new« to this position after only a few months of service, we suspect some »old (especially male) politicians« in the EU bodies, perhaps also »bureaucrats« may be »guiding« you according to their plans. Which is quite expected and can be understood.

However, you will soon have to fully accept and continue the role of a true »mother«, honest with her »children«, citizens of EU. When a person's inner nature is honest and human, their thoughts, words and actions must also be honest and humane. If not, things soon start a bad turn for them.

We therefore expect you personally and the EU Commission to be honest and humane towards us, citizens of the Republic of Slovenia, we expect you to absolutely and as soon as possibly resign from »imposing dangerous microwave 5G and Wi-Fi technologies« on to our citizens and to treat other citizens of the EU members in the same manner, as they too do not deserve such microwave deception and doom from the EU Commission according to the destructive plans of Obama's USA and China.

Nobody from EU or USA or elsewhere has the right to controversially endanger our health, the environment, our sovereignty in this area, which are all protected by the Constitution of the Republic of Slovenia and the laws of the Republic of Slovenia. The Republic of Slovenia has never delegated such disputable powers to the EU or any other international institution. This is also guaranteed by the UN Declaration of Human Rights.

The attachments therefore contain some professional materials - scientific studies, which each "leader" must review and listen to, if there is at least a little humanity in them. (Dr. Graham Downing 's lecture is also very important, as he talks about the new Holocaust with 5G and artificial intelligence, which is already being controversially and inhumanely implemented in some places!).

You have this humanity in you, but you also have to radiate it and manifest it towards your fellow humans. You have even studied emergency medicine in Hannover, which is also your great personal advantage in this position, as the situation in the EU is growing extraordinary urgent... in need of healing... and of a spiritual awakening.

If EU leadership is not increasingly fair, the EU will fall apart by 2024 at the latest, probably even before the end of your term of office. This will also become clearer to you as the events unfold. Natural, moral, and cosmic laws will no longer allow deception to continue on people of this planet.

A determined settlement with evil elites has begun in the USA and will spread to Europe and elsewhere in the world... justice will fall on the dishonest and fair and just regulation will be established for the people and for the nature of the planet Earth...

You may have heard about this in the EU Commission as well... That is also the reason we are trying, including with this letter, to do as much as possible to insure a peaceful transition to a new and better future for all citizens of the EU. Try to understand this in the EU Commission as well and do the best in your ability to participate in this process, each one according to their own karma...

Dear Madam President!

We wish you many correct and humane decisions and actions in your future work, including in relation to our appeal - complaint from the Republic of Slovenia.

We nature conservationists in our selfless efforts to protect people from the devastating 5G and WI-FI technology – every day turn for help to Christ... the supreme master and teacher of Life... in all universes... to help us, to guide us, to direct us and also to protect us from evil... on this path for the common good of all.

The EU also has its foundations in Christianity, so the EU Commission must also take this into account, including God's commandments - do not kill, and also the principle - do not wish (bad) for your neighbor, what you do not want for yourself.

We therefore ask you personally and the EU Commission, to take these foundations of Christianity into account, even in the matter of the controversial microwave technology in the EU and in the Republic of Slovenia. An honest Christian mother will never betray her children for the plans of the wicked...

We ask and look forward to your personal sincere response within a reasonable time, Madam President of the EU Commission, Ursula von der Leyen.
