**II. STRONG COMPLAINT TO THE EU PARLIAMENT - BECAUSE OF SILENCE AND IGNORANCE OF THE EU COMMISSION**

A) IN CONNECTION WITH OUR COMPLAINT TO THE EU COMMISSION OF 6.6.2020 DUE TO CORRUPTION WITH THE COMMISSION AND OTHER EU BODIES IN CONNECTION WITH THE FINANCING OF CERTAIN INADMISSIBLE INTERVENTIONS t.i. BUILDING IN HIGHLY PROTECTED NATURAL AREAS ALSO FROM EU FINANCIAL RESOURCES AND ALSO DUE TO CORRUPTION AT THE AUTHORITIES OF THE REPUBLIC OF SLOVENIA – EVEN BEFORE, BECAUSE OF THE CORRUPTIVE BRIBERY OF THE MUNICIPALITY OF HRPELJE KOZINA WITH 440,000 EUROS, AS WE SUSPECT, SO THAT HIGHLY PROTECTED NATURE RESERVE GLINŠČICA WAS CONTROVERSIALLY EXCLUDED FROM THE PROTECTION OF NATURA 2000 AND WITH THIS SERIOUS FRAUD THEY ENABLED THE BEGINNING OF WORKS FOR THE CONSTRUCTION OF THE DISPUTED ROUTE FOR UNNECESSARY (AND EXTENDED) SECTION 2 OF THE RAILWAY KOPER – DIVAČA.

B) ALARMING COMPLAINT DUE TO THE ATTEMPT OF THE EU COMMISSION TO ATTACK THE CITIZENS OF THE REPUBLIC OF SLOVENIA (RS) WITH ITS ILLEGAL INADMISSIBLE IMPOSITION OF A VERY DANGEROUS MICROWAVE AND MILLIMETER MOBILE TECHNOLOGY 5G ALSO IN THE RS, ALTHOUGH TO THE COMMISSION IS WELL KNOWN THAT IN THE RS WE HAVE A MORATORY ON 5G SINCE 5 DECEMBER 2019, BECAUSE THE RESPONSIBLE MINISTER AT THE MINISTRY OF PUBLIC ADMINISTRATION, MR. RUDI MEDVED APPLIED THE PRINCIPLE OF PRECAUTION DUE TO CONCERNS REGARDING THE IMPACTS OF 5G ON HUMAN HEALTH IN THE RS - ACCORDING TO ARTICLE 191 OF THE TREATY ON THE OPERATION OF THE EU AND ARTICLE 8 OF THE RS ENVIRONMENTAL PROTECTION LAW.

IN MANY OTHER EU MEMBER STATES, THIS 5G AND WI-FI ATTACK (ALSO IN THE REPUBLIC OF SLOVENIA WITH WI-FI ONLY) HAS ALREADY BEEN CONTROVERSIALLY EXECUTED IN 2019, UNDER DIRECTIVES... OF THE EU COMMISSION HEADED BY MR JUNKER. THIS IS ALSO WHY IN THE SPRING THIS YEAR THERE WERE IN THESE »5G - COUNTRIES OR 5G REGIONS FROM 400% TO 800% MORE DEATHS DUE TO CORONA VIRUS THAN IN RS. FOR EXAMPLE: IN ITALY WITH 5G THERE WERE IN THE SPRING 2020 APROX. 30 TIMES MORE DEATHS ON 1 MILLION PEOPLE DUE TO CORONA VIRUS THAN IN RS, WHERE WE DON.T HAVE 5G. ALTHOUGH THE NEW COMPETENT MINISTER AT THE MINISTRY OF PUBLIC ADMINISTRATION, MR. KORITNIK, IS ALSO TRYING TO IMPOSE THE KILLER TECHNOLOGY 5G - WE WILL NOT ALLOW THIS SCAM IN THE REPUBLIC OF SLOVENIA!

C) EMPHASIS OF SOME OF THE WORST AND FOR EU CITIZENS MOST UNACCEPTABLE DISPUTES REGARDING THE VERY DANGEROUS EU COMMISSION REGULATION OF 30.6.2020 ON THE LIGHT DEPLOYMENT REGIME OD NEW DANGEROUS SAWAP-5G

## I. COMPLAINT TO THE EU OMBUDSMAN

Honorable Ombudsman, Ms. TEREZA MANDJUKOVA.

On 6 June 2020, we sent our sharp complaint to the EU Commission and also to You, due to corruption in environmental interventions in highly protected nature areas in the Republic of Slovenia and even more due to controversial imposition of dangerous 5G microwave technologies in the Republic of Slovenia by the EU Commission, despite we have moratorium on 5G since 5.12. 2019. And even with the condition of Corona package financial aid for the Republic of Slovenia ....conditioned with the installation of 5G in the Republic of Slovenia, which is highly controversial by the Commission, very inadmissible and exceeding its powers, as the Republic of Slovenia did not delegate to the EU Commission the decision on the construction of facilities and devices dangerous to human health in the Republic of Slovenia.

To date, the COMMISSION HAS NOT ANSWERED US WITH A SINGLE WORD - WHICH IS TOTAL IGNORANCE!

EVEN MORE AND AGAIN, THE EU COMMISSION EXCEEDED ITS AUTHORITY WITH ITS CONTROVERSIAL IMPLEMENTATION ACT WHICH WAS UNREASONABLE PUBLISHED ON ITS WEBSITE JUNE 2020, AS WELL AS THE CONTROVERSIAL STUDY FOR THE LIGHT DEPLOYMENT REGIME FOR 5G LOW-POWER ANTENNAS - SAWAP - PRACTICALLY EVERYWHERE.

THIS IS ALSO CONTRARY TO THE ATTACHED EU COMMISSION STUDY FROM DECEMBER 2019. COMMISSION WROTE EVEN MORE CONTROVERSIALLY IN ARTICLE 5 OF THIS DISPUTED REGULATION: THIS REGULATION SHALL BE BINDING IN ITS ENTIRETY AND APPLICABLE DIRECTLY IN ALL (EU) MEMBER STATE. IT SHOULD START TO BE USED AS EARLY AS 21.12. 2020.

Honorable Ms Ombudsman,

We are sending you a complaint directly about this monstrously dangerous regulation of the commission adopted in June this year, with the attached study from December 2019, whereas we cannot lodge a complaint with the EU Commission first and then wait 2 months for Commission ignorance or silence and lose 2 months again while the danger would go on smoothly!

WE HAVE EMERGENCY CONDITIONS IN THE EU SINCE THE INSTALLATION OF 5G !!!

**We ask you - your official body ex officio - to apply to the competent EU court as soon as possible on your own initiative...to identify unacceptable disputes and serious threats to the health and lives of EU citizens in the articles of this EU Commission Regulation for the deployment of SAWAP, as this would be essentially a new attack on the population with hazardous technologies if this would be realized on 21.12.2020, because 5G is a completely untested technology - essentially a military weapon that should never be used against the civilian population.**

Beside this, 5G is scientifically untested. **We also suggest that the competent court immediately - at the beginning - also issue a temporary injunction or an act to suspend the implementation of this destructive regulation and an act to suspend the operation of all already operating 5G antennas in the EU!**

The health of millions of EU citizens is already endangered, attacked and affected, many of them have already died, also maybe due to the dangerous effects of 5G, also in connection with other diseases, as 5G could first and quickly weakens or destroys the immune system and respiratory system of humans, but it works quietly, imperceptibly for the vast majority of people, until it's too late !!! Authorities may then present the effects and symptoms of 5G dangerous microwaves on humans as the consequences of coronavirus disease, according to WHO guidelines, as suspected.

Honorable Ms. Ombudsman,

**We sincerely and from the bottom of our hearts unselfishly ask you to act wisely, honestly and quickly this time, because you have the highest authority, even for such the most dangerous cases of attacks or endangering human health by dangerous means.** The UN Declaration also qualifies such mass acts of power... as genocide. As well as the Treaty... EU defines such controversial acts (endangering human health and life) as genocide. **Careful scientific research is needed first, followed by a decision FOR or AGAINST 5G.**

As You know, on 6 June 2020 we sent you an important document from the EU Parliamentary Research Service (EPRS) from February 2020, in which they stated the unacceptability of EU exposure standards for existing permissible microwave radiation for the new 5G, because 5G is a completely new technology, completely untested - and even works immediately and "in vivo" on people in the EU. EPRS has also made it clear that new interdisciplinary scientific research, including medical professionals, is needed. **EPRS have therefore applied the EU's Precautionary Principle (Article 191 of the EU Treaty) and the EU Commission - as the EU's executive, this must take into account,** as there is a serious threat to the health and lives of EU citizens since early 2019.

**However, the Commission does not take this into account, nor does it take into account its new study from December 2019, which also imposes new research on the dangers of 5G-SAWAP!**

On behalf of all unsuspecting EU citizens, we therefore sincerely and heartily ask you and suggest that you, too, act extremely humanely and compassionately towards all of us in the EU and that you quickly do everything necessary to eliminate this serious danger and scam with 5G as soon as possible and to stop this at least temporarily, until scientists credibly do their part and complete the necessary research on the effects of 5G on human health.

## I. EU PARLIAMENT

### A. STRONG COMPLAINT TO THE EU PARLIAMENT WITH A PROPOSAL FOR ACTION:

As you, dear Members of the EU Parliament, can see from the attached complaint to the EU Commission (Commission) on 6 June 2020, there are suspicions of serious corruption in the Republic of Slovenia and in EU bodies, especially in the following cases:

- Construction of the disputed sewerage system in the City of Ljubljana (MOL) across the drinking water area for at least 300,000 people, including EU funding of € 80 million.
- Construction of the 2nd track of the Koper - Divača railway is controversial over the RVK water protection area and over the Glinščica nature reserve with highly protected habitats, even with at least 70% - too high an investment price due to corruption. Remember that the Republic of Slovenia is in 1st place with regard to corruption in the world (according to the last international German poll this year), followed by Kenya and then the Republic of Croatia.

OLAF has received several complaints and documents - evidence of undisputed corruption in »2. track... "and refuses to act legally. Is there corruption at OLAF as well ??? After all, EU regulations and 250 million funds of the ECB and another 90 million funds of the EU Commission itself have already been or will be violated, ie a total misuse of 340 million of EU funds !!! That is a severe abuse of protected nature in the Republic of Slovenia too!!! We, the citizens of the Republic of Slovenia, also contribute to the EU budget, so we want clean bills...!

After 2.5 months, the Commission did not respond with a single word, nor about this first environmental part of our complaint of 6.6.2020.

Due to the above, we suggest EU parliamentarians to order an impartial report from the Commission in this part of our complaint and to then demand its lawful conduct and compliance with all EU regulations and all regulations of the Republic of Slovenia (including Natura 2000) when co-financing investments in the Republic of Slovenia, so

there will be no more harm than good for our citizens of the Republic of Slovenia and for our precious natural environment.

Thank you in advance for your contribution in this case and we ask you also for your written response.

**B. ALARMING COMPLAINT TO THE EU PARLIAMENT... DUE TO THE ATTEMPT OF ATTACK OF THE EU COMMISSION ON THE CITIZENS OF THE REPUBLIC OF SLOVENIA BY IMPOSING THE DANGEROUS 5G TECHNOLOGY IN THE REPUBLIC OF SLOVENIA AND BECAUSE OF THE EU COMMISSION'S ATTACK ON EU CITIZENS IN EU MEMBER STATES WITH A 5G NETWORK ALREADY ESTABLISHED IN 2019 UNDER EU COMMISSION DIRECTIVES.**

1. Honorable Mr. President, Vice-Presidents of the EU Parliament and ladies and gentlemen, members of the EU Parliament from all EU Member States,

In the second part of our complaint to the Commission dated 6 June 2020, to which the commission did not respond with a single word in 2.5 months (the complaint dated 6 June 2020 is attached), we addressed the Commission very humanely, t.i its President and three Commissioners, to draw serious attention to the serious dangers to human health and life due to use of 5G hazardous microwave technology, which has not been tested or is already proven to be very dangerous according to research on the effects of 2-5G on human health.

We also attached and strongly emphasized the expert opinion of the EU Parliament's Research Service, which clearly stated its opinion in the document from February 2020, that this is a brand new technology 5G, that the current security standards are old over 20 years... and do not correspond to 5G, that new interdisciplinary scientific research is needed, also with medical experts... on living beings... and than follows the adoption of new standards !!!

We also pointed out in the complaint that it is inhumane and unfair that the commission demands from the Republic of Slovenia that it must introduce inadmissible 5G technology as a condition for obtaining financial resources from the Corona EU aid package. **This is a great shame for the whole EU!**

The Commission has not replied to us, nor has it answered why it does not comply with the EU Precautionary Principle (Article 191 of the Treaty on the Functioning of the EU), which was triggered by the EU Parliament's Research Service with its undisputed opinion. The Commission also did not answer why they did not follow the Precautionary Principle, which is valid in the Republic of Slovenia since 5 December 2019, when Minister Mr. Rudi Medved at the Ministry for Public Administration introduced it and activated a moratorium on 5G in the RS.

**2. The Commission has therefore knowingly and very controversially violated the undisputed expert opinion of the EU Parliamentary Research Service by failing to issue an urgent act (directive or similar takoj) immediately after February 2020 to stop the operation of 5G throughout the EU, which was illegally imposed by its predecessor - the President Juncker with his Commission... and dictation from the USA.**

**This is indisputably imposed on the Commission by Article 191 (Precautionary principle) of the EU Treaty, which is a fundamental act for the functioning and existence of the EU and also absolutely protects the health and lives of EU citizens, especially in cases of untested hazardous technologies such as 5G,** which until now was only a military weapon, but has now been disguised by manufacturers - after the instructions of the destroyers of humanity - the evil billionaire elites - into modern ultra-fast mobile phones, with the excuses of "rapid economic development and progress". But in reality it is clearly an attempt to destroy man and to transform man - a spiritual being into an "obedient working zombie", until he dies - to the goal of the "golden billion".

Once 5G is installed, all that is missing is a "necessary nanochip", with an injection of "anti-coronavirus" vaccine and a circle with "artificial intelligence (AI)", which does not even listen to the Earth "rulers" who install it, it would be concluded. Man as a spiritual being can then say goodbye, from all positions of management - decision making. Even the EU Parliament would no longer be needed because these elite groups that run the AI centers want to decide everything themselves and no one on Earth could control or command them anymore.

3. Honorable all in the EU Parliament!

**According to our letter - the complaint of us sustainable farmers from Slovenia to you - the highest representatives in the EU, which you must read in its entirety, you will come to the biggest - for some perhaps the most difficult - turning point in your life: You will have to decide after deep, serious and selfless consideration: for man - for the further development and spiritual progress of humanity, including you and your loved ones, or (God forbid) for the destruction of humanity in large part - to reduce humanity by about 7, 5 billion to 0.5 to 1 billion people, who would be zombies or slaves with chips in the service of inhuman billionaires. This must be clear to you here, now and forever !!!**

**No one should opt for this second option, because no one has been elected to the EU Parliament for this destructive purpose, with the trust of your voters in your countries! Now you need to absolutely fulfill that trust of your voters! PLEASE AWAKEN ALL HUMANITY AND COMPASSION TO PEOPLE IN YOU.**

However, we suspect that someone outside the EU Parliament, possibly only a few members of the EU Commission, is pursuing a different policy that is not in line with the Treaty on the Functioning of the EU, is not in line with the UN Declaration of Human Rights, is not in line with EU Constitutions. it is also not in accordance with the Constitution of the Republic of Slovenia. As if they work for billionaires - the destroyers of man on Earth. This will also be shown soon in the future!

We, the more responsible people from the Republic of Slovenia, very much regret that the Commissioner from the Republic of Slovenia is so very bureaucratic and so insensitive to us citizens in the Republic of Slovenia that he does not see or is not aware of and does not react for the protection of the rights to health and life of the citizens of the Republic of Slovenia and other citizens of all EU members. Unfortunately, members of the EU Parliament from the Republic of Slovenia are also "sleeping", apparently very soundly, despite these fatal mistakes of the EU Commission

The deputies from LMŠ party, whose minister initiated the Precautionary Principle in the Republic of Slovenia on 5 December 2019, are sleeping the most, and they smoothly betrayed this minister, both in the Parliament of the Republic of Slovenia and in the EU Parliament! We do not yet know exactly whether these controversial commissioners are leading this deception over the people in the EU under the dictates of the United States, more "on their own initiative "or with full awareness of the President of the EU Commission.

4. We suspect that a similar scam has been going on for decades with increasingly dangerous vaccines in the EU... according to directives from the WHO teams, which are under the greatest influence of the well-known and very controversial US billionaire...

**Also, the US-planned fraud with dangerous DNA vaccines... also with the planned nanochips in the vaccines for the hellish Trojan five ("inflated" coronavirus numbers + vaccine "against COVID-19" + chips + 5G + AI, (all vaccines have been untested for decades, even in RS)) will obviously have to be considered and stopped in due course by the EU Parliament and the EU Ombudsman, as the basic task of the EU and the EU Parliament, including in the Treaty on the Functioning of the EU, is to protect the health and lives of EU citizens...**

**5. In the following, we must emphasize to all of you in the EU Parliament another catastrophically dangerous mistake or deliberate act of violating EU regulations and violating the regulations of all EU member states by the decisions of the EU Commission:**

On 30 June 2020, the Commission published very controversially a study on its website, the author and contributor of which is also the EU Commission itself.

This study was conducted in collaboration with three experts from England and talks about small 5G cells or about SAWAP technology 5G. The publication of this study itself would not be so bad if the publication of this study were not followed by the publication of an even more controversial and dangerous for EU citizens and absolutely unacceptable Commission Implementing Regulation, published in the Official Journal of the EU on 20 July 2020.

In the Article 5, which is the last article of this regulation, the Commission wrote very controversially and even more unacceptably: This regulation is fully binding and directly applicable in all Member States. (of course - EU members, so also the most controversially in the Republic of Slovenia - in our country).

At the end, unfortunately, it is written: "For the commission - President Ursula VON DER LEYEN". This confirms the suspicion that the President is personally fully involved in this worst fraud in the history of the EU over the health and lives of EU citizens. Whether she is aware of everything or not, it will be shown... She is fully responsible with her signature... if she personally signed it.

Below we will emphasize the complaint on some of the most dangerous facts, the most untenable claims, contradictions, also the dangerous findings in this EU study, which were not taken into account and denied by the Commission.

However, many controversial and important issues related to this study and in connection with the inadmissible disputed regulation of the commission are discussed and commented on in our study material in the attachment entitled: **PROFESSIONAL COMMENTS OF THE ENVIRONMENTAL ORGANIZATION ZSKS ABOUT LIGHT DEPLOYMENT REGIME OF SAWAP 5G IN THE EU...** from 9.8.2020.

It should also be noted that the Commission, which is also the co-author and contributor of this controversial study, very duplicitously tried to insure itself against liability in the introduction due to the possible consequences that could arise from considering this study. This tells us that the Commission is aware that there is a serious error with this implementing regulation and with this study, which is the main basis for this controversial regulation.

**The Commission therefore completely misused this study as a basis for its regulation, t.i. "criminal order" for the mandatory installation of very dangerous for humans SAWAP 5G small-cells throughout the EU, although they know very well that everything is insufficiently checked, insufficiently safe and uncontrolled, as it follows from this study itself.**

**C) EMPHASIS OF SOME OF THE WORST AND FOR EU CITIZENS MOST UNACCEPTABLE DISPUTES REGARDING THE VERY DANGEROUS COMMISSION IMPLEMENTING REGULATION OF 30.6.2020, WHEREAS THE COMMISSION HAS NOT TAKEN INTO ACCOUNT:**

1. Already in the introductory part of its study about SAWAPs, which was published as early as 3 December 2019, the Commission therefore ambiguously wrote (the original of this EU study on SAWAP-5G is also attached to this complaint), despite the fact that the Commission too co-authored this study, commissioned it and also paid heavily with EU taxpayers' money, the Commission published very "cautious" notices, in order to try to avoid their own responsibility for any dangerous consequences of using the "Information contained in this study", which means in fact "of using the study as a whole", **as the Commission used this study as a basis for the disputed implementing regulation, which could mean "organized mass attack on the EU population", as we suspect in ZSKS, if this regulation is implemented after 21.12.2020, as stated in the regulation that it must take place after that date in all EU Member States.**

In this study, it is also written that **SAWAP 5G network requires from 100 to 1000 times more cells or Small 5G stations, as has been the case with 2G-4G technology**, so every few 100 m of radius there would be a new cell -"small 5G", with features - very similar to the current already controversially installed and working **5G base stations, which also significantly contributed to the high number of deaths "due to coronavirus" this spring in Member States with 5G networks or in regions with 5G networks; as a Spanish study (carried out this spring) in point 7 showed that in regions with 5G in Spain there were 400-800% more deaths during the COVID-19 epidemic than in regions without 5G in Spain.** (The Spanish study is attached to our complaint to the EU Commission on 6.6.2020).

**This must be verified by those responsible in the EU Parliament and other EU bodies in order to clearly show the responsibility of the previous and current EU Commission for such a large number of deaths in 5G regions in other 5G EU Member States, as the EU Commission under Juncker imposed with its directives and other controversial acts, dictated by Obama's U.S., to many EU members this dangerously untested "military, murderous 5G technology" disguised as "atracitve fast" disastrous smart phones.**

Thus, **in northern Italy**, where, according to the command of the EU Commission, 5G networks were set up by 30 June 2019, **there were 30 times more deaths per 1 million people in the spring than in our neighboring country** - the Republic of Slovenia, In Italy there were more than 1,600 deaths and we only 54 per million. Very similarly, there were aprox. 10 times more deaths in other western countries and regions with well-established 5G network (Spain, France, of course similarly in the USA, etc.), compared to the Republic of Slovenia.

**2. The EU Commission has been aware of the opinion of the EPRS since 11 February 2020, which proposed the EU Precautionary Principle (Article 191 of the Treaty on the Functioning of the EU...) and new more detailed expert research, including medical experts, on the biological effects of 5G on living beings. Immediately after that, in mid-February this year, the Commission should declare a moratorium on all already operating unverified dangerous 5G network and initiate new emergency research, as well as set new standards of exposure safety limits, as proposed by the EPRS to the Commission. But the Commission didn't do that ...**

**3. Even more and even earlier, the new EU Commission, headed by Ms. Ursula von der Leyen immediately after December 2019 should declare a moratorium across the EU on the operation of all 5Gs and the installation of new 5Gs, because the same Commission published this new study on SAWAP - 5G, which the Commission ordered and paid to three English co-authors.**

The Commission was well aware of what was at issue for the use of SAWAP - 5G in this study. The Commission was equally aware that this study also triggered the EU Precautionary Principle (Article 191 of the Treaty on the Functioning of the EU...), as it proposed a call for new detailed multidisciplinary scientific research and new exposure guidelines, etc., The EU study revealed that 5G is not verified, that emmissions can not be measured, that there si an absence of procedures and technology for testing and measuring adverse effects on humans in 5G, SAWAP-5G, etc.

**4. All this and much more dangerous facts the Commission learned from this study and should therefore immediately initiate a moratorium on 5G in December 2019 - or. apply the EU Precautionary Principle... BUT THE COMMISSION DIDN'T DO IT! WHY?**

**However, this suspension should be carried out by the Commission no later than February 2020, following the EPRS expert opinion, which also called for new research and proposed the activation of the EU Precautionary Principle and noted that EU standards for safe exposure to RF EMP emissions are not appropriate for 5G new technology because they are over 20 years old, etc**

**5. The behavior of the EU Commission is therefore from February onwards 2 times more unwise, and even more unwise from 30.6.2020 onwards, when it published a monstrous Implementing Regulation that would mean an attack on EU citizens with even more dangerous SAWAP - 5G technologies, if it started to be implemented on 21.12.2020 and started inadmissible covert and insidious genocide against people who trust the EU Commission.**

**That is why we wrote in the ZSKS complaint that the EU parliamentarians have a very responsible task ahead of them: It is a question: to be or not to be, as Shekspeare wrote!**

It is a severely planned tragedy according to the plans of evil billionaire elites from the USA, so the **EU Parliament has no choice and no deviation: it must stop the commission or its dangerous Implementing regulation on SAWAP -5G and also to stop the already installed and operational 5G stations across the EU or it must dismiss this dangerously indiscriminate Commission that has forgotten what its main and sacred duty is: to look after the well-being of EU citizens. **The EU Parliament must therefore immediately, if possible at its first autumn session, consider:**

**a) this unreasonable and fratricidal commission Implementation regulation SAWAP - 5G of June 2020 and demand its repeal.**
